

# Visiting Physician Program (VPP) Fact Sheet

The EvoEndo Visiting Physician Program, or VPP for short, is a clinical education initiative that connects current physician and facility champions of our technology with interested clinicians who would like to learn more about how the product can be integrated into their own practices by observing live cases and consulting in-person with respected clinical peers and colleagues.

At EvoEndo, we believe clinician education is essential to the successful advancement of medical technology and are dedicated to the idea that the most effective way to deliver that education is in-person and via a peer or colleague.

We are sensitive to the need to maintain a healthy separation between industry and healthcare delivery. To that end, we contract with independent faculty to serve as Key Opinion Leaders who are reimbursed for their time but have sole discretion over educational content and opinions expressed during their presentations. Our belief is that this technology and its benefits to patients and clinicians are strong enough to stand on their own merits, and our involvement does not need to go any farther than the front door.
